From TX: North on I-25 to Exit 147 (I-25 Bus/California St) / North on CA St to US-60 (Spring St) / West on US-60 / North on AZ Hwy 77 in Show Low. West on Paper Mill Rd in Taylor approx 1 mile to NATC on right.

From SE AZ: Hwy 77 North from Tucson to Taylor. Left on Paper Mill Rd approx 1 mile to NATC.

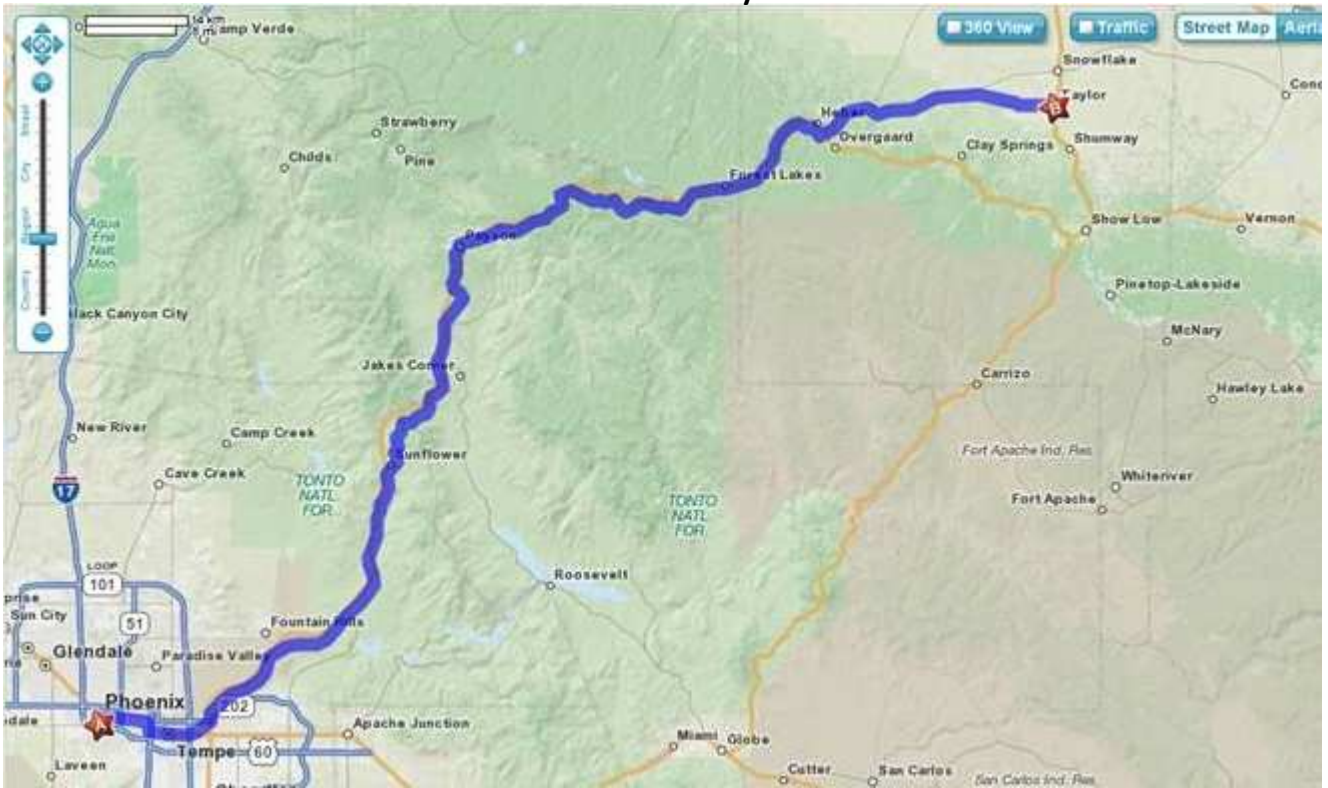

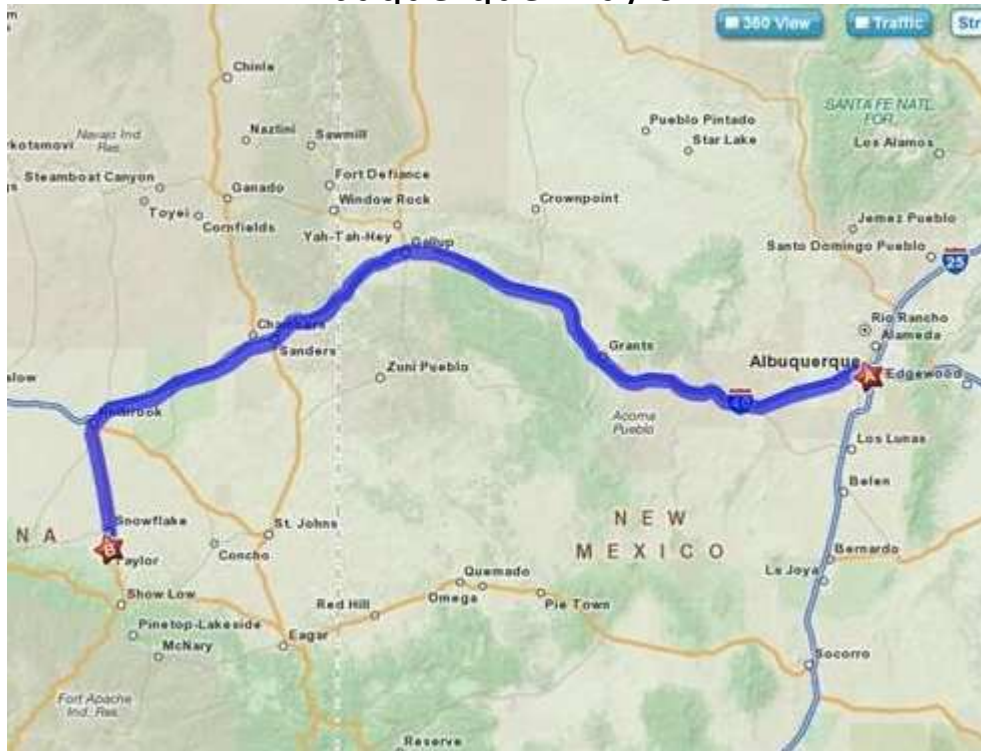
